REACH REGULATION SGS ONE-STOP SOLUTION

Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) Regulation (EC) No. 1907/2006 entered into force on June 1, 2007. It aims to protect human health and the environment from the risks that can be posed by chemicals, while enhancing the communications of hazardous substance information along the supply chain. It is managed by the European Chemicals Agency (ECHA) and applies to all chemicals imported or produced in the European Union (EU).

ARE ELECTRICAL AND ELECTRONIC PRODUCTS AFFECTED?

REACH applies to substances, mixtures and articles, and therefore impacts most products placed on the EU market. Electrical and electronic products, such as those listed below, are affected by REACH as they are classed as 'articles', such as:

- Television
- Refrigerator
- Light bulb
- Toaster
- Electronic toy
- Printed circuit board
- Electronic component
- Packaging



HOW TO COMPLY WITH THE REACH REGULATION?

Articles, electrical and electronic equipment placed on the EU market need to focus on the management requirements of Candidate List of Substances of Very High Concern (SVHC) and restricted substances in ANNEX XVII under the REACH regulation. However, organizations may take different counter measures to the REACH requirements depending on their position in the supply chain (see below).
