TYPES OF WRAP CERTIFICATE

WRAP have adopted a three-level facility certification programme. The purpose of the programme is to award participating facilities the appropriate level of recognition for their progress in achieving full compliance with the WRAP Production Principles over a period of time.

There are three levels of WRAP certification –Platinum, Gold and Silver, and the validity periods are two years, one year, and six months, respectively.
